- (i) Rs. 2000/- as onetime payment per student at the time of admission towards admission / registration /recognition fee and an amount of Rs. 500.00 shall be remitted by the institution to the concerned University.
- (ii) Rs.1500/-per annum per student during the course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.

The requisite fee is to be paid in the form of D.D. drawn on any nationalized bank in favor of "Registrar, JNTU Anantapur" payable at Anantapur. **Clearance of admission of the candidates is subject to payment as per the details given above.** As per item no. (ii) mentioned above, Rs.1500/- per annum per candidate admitted shall be remitted to the University by the college during the remaining years of course. You are requested to produce the following certificates/records for issue of clearance for the candidates admitted at your institution in MTech/MPharm/Pharm.D (PB) courses during the academic year 2010-11.

- (v) List of candidates admitted through spot admissions and approved by APSCHE, Hyderabad.
