You are requested to take note of the following.

The private Unaided Colleges offering Pharm D program are permitted to collect

- (i) Rs. 2000/- as onetime payment per student at the time of admission towards admission / registration /recognition fee and an amount of Rs. 500.00 shall be remitted by the institution to the concerned University.
- (ii) Rs.1500/-per annum per student during the course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.

In view of the above, the colleges are required to remit an amount of Rs.2000/- (Rs.500 towards Recognition fee + Rs.1500/- towards common service rendered by the University) per candidate admitted at the time of entry. The requisite fee is to be paid in the form of D.D. drawn on any nationalized bank in favor of "Registrar, JNTU Anantapur" payable at Anantapur. **Clearance of admission of the candidates is subject to payment as per the details given above.** As per item no. (ii) mentioned above, Rs.1500/- per annum per candidate admitted shall be remitted to the University by the college during the remaining years of course.

You are requested to produce the following certificates/records for issue of clearance for the candidates admitted at your institution in I year Pharm D course during the academic year 2010-11.

1. Two sets of photocopies of

- (i) Latest AICTE/PCI approval
- (ii) Latest JNTUA affiliation letter.
- (iii) List of candidates admitted by Convener EAMCET 2010 with approval Seal,
- (iv) List of candidates admitted under Minority/Management/Sponsored quota (if applicable) and approved by APSCHE, Hyderabad.

(v) List of candidates admitted through spot admissions and approved by APSCHE, Hyderabad.

Note: Please note that all the original copies of above are to be submitted without fail for verification and return.

You are requested to enter legibly the Roll No. cum hall ticket number (10 digits) allotted as per the JNT University Anantapur, Anantapur guidelines against each candidate on the two sets of photocopies of approved lists. It is also requested that each page of these two sets of photocopies of the approved lists should be signed by the Principal and Secretary of the Management duly affixing their seals.

2. A Soft (M.S. word document in CD) and Hard copies of a separate list of names of students (branch wise) along with their ten-digit hall ticket numbers in **serial order** only.

3. You are requested to submit hard and soft copies (MS word document in CD) of students' particulars in the following formats. ***Each page of the hard copy should be signed by both the Principal and Secretary duly affixing their seals without fail.***
