As per G.O. Ms.No.216 cited, you are requested to take note of the following.

The private Unaided Engineering including Pharmacy and Architecture colleges are permitted to collect

- Rs. 2000/- as one time payment per student at the time of admission towards admission / registration /recognition fee and half of such amount of Rs.2000/- i.e.Rs.1000/- shall be remitted by the institution to the Concerned University.
- Rs.1500/-per annum per student during the course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.

In view of the above, the colleges are required to remit an amount of Rs.2500/- (Rs.1000 towards recognition fee + Rs.1500/- towards common services rendered by the University) per candidate admitted at the time of entry. If an amount of Rs.1500/- has already been paid by the college per candidate admitted, you are required to remit the balance amount i.e.Rs.1000/- per candidate admitted during the academic year 2009-10. In case, no payment is made earlier, **you are required to make the total payment i.e.Rs.2500/- per candidate admitted.**

**The requisite fee is to be paid in the form of D.D. dated 06.10.2010 drawn on any nationalized bank in favor**

of "Registrar, JNTU Anantapur" payable at Anantapur. Clearance of admission of the candidates is subject to payment as per the details given above. As per item no. (ii) mentioned above, Rs.1500/- per annum per candidate admitted shall be remitted to the University by the college during the remaining years of course. You are requested to produce the following certificates/records for issue of clearance for the candidates admitted at your institution in I year Pharma.D (P.B) course during the academic year 2010-11.

- ✓ Two sets of photocopies of latest AICTE/PCI approval & JNTUA affiliation letter.
- ✓ List of candidates admitted by the Convener EAMCET 2009 with approval seal,
- ✓ List of candidates admitted under Minority Quota, Management quota (if applicable) and approved by the Convener EAMCET - 2009 and Secretary APSCHE.
- ✓ List of candidates admitted through spot admissions and approved by APSCHE.
- ✓ Proof of payment, if earlies paid. (Photocopies of covering letter & DD)

*Note: Please note that all the original copies of above are to be submitted without fail for verification and return.*

You are requested

- to enter legibly the roll No. cum hall ticket number (10 digits) allotted as per the JNT University Anantapur guidelines against each candidate on these two sets of photocopies. It is also requested that each page of these two sets of photocopies of the approved lists should be signed by the Principal and Secretary of the Management duly affixing their seals.
- to submit a Soft (M.S. word document in CD) and Hard copies of a separate list of names of students along with their ten-digit hall ticket numbers in **serial order** only.
